## \*Notes

- PLEASE NOTE these ratios, facilitator qualifications, and maximums are valid only for activities <u>at our Council's properties and for Summer Camp</u>. If anyone is planning an event at another property, or a Troop Trip, they should follow the requirements in Safety Activity Checkpoints.
- Activities are displayed above in clusters based on area (waterfront, teambuilding, etc.), so that you can plan for girls to progress through each area as they grow up, eg: a Brownie could start with Co-Op Games, then do the Co-Op Course as a Junior, and the Advanced Course and Phoenix Tower as a Cadette.
- If you would like to use a volunteer facilitator and believe that they have a certification that would qualify as 'equivalent' to the listed requirements, please contact Customer Care to confirm BEFORE reserving your area.
- ARC = American Red Cross
- Facilitators CANNOT 'double up' on what they are supervising—if you are running Canoeing and Kayaking at the same time, you will need TWO facilitators.
- If using both Corcl Boating and Stand-Up Paddleboarding simultaneously, you may instead have one Waterfront Lifeguard oversee both activities overall while two Small Craft Safety certified facilitators lead them.
- \*You must always at least pay for as many girls at the listed session <u>minimum</u>. Groups providing their own facilitator will not pay the facilitator fee per girl, but will still need to enter at least the minimum number in the registration system to book online.
- \*Session <u>maximums</u> with an \* can be *doubled* IF you are providing <u>at least</u> one certified volunteer facilitator. Kayaking maximum increases to 18 total. Please discuss with Customer Care for pricing. Session maximums without an \* cannot be doubled.
- Session maximums MAY be exceeded for all-camp activities <u>with Camp Director's</u> <u>permission</u>, but instructor/watcher : participant ratios MUST be followed.
- <sup>§</sup>Watchers <u>must be trained BEFORE session begins</u> once trained, they can serve as Watchers for a full year before undergoing an additional training/skills check. Groups with Daisies must have 1 watcher per 6 participants at <u>Fishing</u> and <u>Creek Stomping</u> only.
