Why Participate?

At the time of your choosing or throughout the year, your troop can fundraise to help other girls in the Hornets' Nest Council learn, develop, and grow. Sister to Sister is a campaign that encourages Girl Scouts and their families to participate in philanthropy while providing the Girl Scout Experience to all girls. Funds raised through Sister to Sister directly offset the cost of Girl Scouting by supporting programming, events, and financial assistance. Nearly 1 of every 8 girls in our Council receive financial assistance. Sister to Sister fundraising helps to provide this support.

Guidelines

- To be eligible, troops **must** participate in **both** Fall Product and Cookie Sales
- All tax-deductible donations must be paid directly to "Girl Scouts Hornets' Nest Council", donations in the amount of \$50 or more will automatically receive a tax donation receipt.
- GSHNC **prohibits** fundraising activities that are a game of chance (raffles, Bingo, etc.)
- GSHNC **prohibits** the sale or endorsement of commercial retail products (coupon books, Autobell vouchers, Krispy Kreme Donut sales, etc)
- **Troop Money Earning Application** must be completed if an event or sale is being held to benefit the Sister to Sister campaign
- Troops can designate up to a 50% split of Sister to Sister donations raised be applied to the Troop. This split **must** be indicated in the memo field of checks received.

Fundraising Ideas

Matching Gifts

Many companies match donations of their employees. Check with your employer and submit your personal donation for a company match!



Community Spirit Nights

Local restaurants and retail stores often support area nonprofits through Give Back nights and will donation a percentage of sales.



Volunteer Hours Grants

Does your employer make charitable contributions to nonprofits for volunteer hours? Companies like Walmart, Microsoft, and Kohls have employee volunteer programs.



Holiday Gift Wrapping

Your local mall, shopping center, or retail store may allow your Troop to host a gift wrapping station for donations during the holidays!



Frequently Asked Questions

How can I describe the Sister to Sister campaign to parents?

The Sister to Sister campaign provides all girls in our area an opportunity to benefit from Girl Scouts regardless of their ability to pay for membership or programs fees. Nearly 1 out of every 8 girls in our council receives some form of financial assistance. Donations raised through Sister to Sister help support this funding.

What is our Service Unit goal and how is it determined?

Service Unit goals are determined by the average of the three prior years of donations made to the Sister to Sister campaign within your Service Unit. Your Service Unit Leader can share information and help with goal setting within your Troop.

Can I spread my payment out over time?

Absolutely! Our development team can help you set up recurring credit card payments. E-mail development@hngirlscouts.org for more information.

Where does the money go?

100% of proceeds raised through this campaign support our financial assistance fund to pay for uniforms, materials, and program registration fees for those unable to pay for those things on their own. The cost of supporting one girl for a year of Girl Scouts is approximately \$410.

Why are all donations made payable to GSHNC?

GSHNC is a federally recognized nonprofit with 501c3 designation, which allows the Council to provide tax deductible receipts to donors. Tax receipts are provided automatically for personal donations of \$50 or more and can be provided upon request for any amount under \$50.

What if my family cannot afford to give?

We understand! We want Girl Scouts to be there for every girl which is why we offer financial assistance. It is also why we ask families who can make a donation to join us in our Sister to Sister campaign efforts. Families support GSHNC in many wonderful ways by giving their time, talents, and treasures.
